


Recreational Activity on Long Lake

18	In general, we think the lake management has been good and our neighbors have been respectful of nature and eschewed over-development. Our family has frequented Long Lake since the 1920s
	s multiple generations enjoying it. We are personally committed to doing our part to preserve it for future generations.

Owned on Long Lake since 1996. The invasive milfoil was on the rise and not until the association was formed and implanted chemical eradication did I see results in milfoil reduction. The plans now are not working as the 2019 season looks a lot like the mid to late 90's. The present technique is not successful. Blankets of weeds (other than native species) are everywhere except in open water. The quality of the lake is diminishing both in rapid plant growth(weeds) and the reduction of original game fish.

The DNR has planted 1000's of trout, why? Because one DNR biologist said "we have plenty of musky lakes but few trout lakes.

19 Long, Spectacle & Beach Oak Lake. Since 2013 the DNR has stocked 304 muskellunge in Long Lake. The planted in 2017-2018 a total of 20,717 lake trout: therefore they are using Long Lake to propagate trout with a small or minuscule amount of muskellunge.

The few trout lakes available is their intention for Long Lake.

That species of game fish has declined since 1996 when I first bought on Long. Its a shame to see a former good to better than average musky fishery decline.

- Our family fully supports the work that the board has done with UW Milwaukee on the fishery project. We really wish the DNR would recognize our efforts in some substantial way. There needs to be a reward for our district going above and beyond.
- 21 I appreciate the work that the Lake District Board has done for many years. This survey is a very thoughtful approach to better understand membership. Thanks for your efforts.

My math was off on a previous question, the family has owned the house on Long lake since 1946, we have been on the lake for 74 years. I have been coming to the lake for 60 years. From my memory the fishery started to degrade in the late 80's. I recall it coincided with the first I herd of the smelt in the lake.

I fully support the lake district and their efforts to manage the invasive threats to Long lake.

Thank you for all your efforts to help keep Long lake the special place it is.

- 36 Very happy with annual meeting and learning about the year and its impact on the lake.

- 38 Long Lake has been and is a great resource. Long Lake District has become a very expensive yet totally ineffective layer of governance over this resource.
- To many rules hinder most fun. Teaching respect and kindness to neighbors is most important but not through regulation. New neighbors/owners are going to make noise for a few years. Let it go.
